AND


Academy for Skill Development, Surat, Gujarat (hereinafter called "**ACADEMY**") which expression, shall, unless repugnant to the context or meaning thereof, include its successors and assignees, as the case may be) of the **Second Party**.

WHEREAS is "Learn to Work" as Vision, On the job learning as Mission, so as to develop an optimal level of skill as value.

WHEREAS CPC, Odisha has a vision to get the students pursuing Diploma and ITIs Education & Training placed in reputed Companies. And also facilitate Companies in form of providing database of interested students against openings of that Company and making arrangement for Campus drives to be organized centrally.


NOW THEREFORE, both parties after intense discussion have desired to work together in common areas as per following terms and conditions:

1. The **MoU** shall be effective from the date of its signature.
2. The period of **MoU** shall be for three years to be extended by mutual consent for a further period of three years or more. This can be terminated on mutual consent of both the parties, without any notice thereon.
3. **CPC, Odisha** propose to conduct campus drive centrally / decentrally for the benefit of the students pursuing the Diploma Education & ITI Training across



the State of Odisha by providing necessary logistic support with other technical & knowledge support from the Company.

4. The **Company / Third Party** shall register in CPC website i.e. www.cpcdetet.nic.in and shall attempt to conduct at least one campus drive in a year, if required, through CPC, Odisha.
5. The **Company / Third Party** should provide their requirement with criteria for the Campus drive in the official portal of Central Placement Cell, as and when necessary.
6. The **Company / Third Party** shall depute the companies' authorized representative along with their team for presentation regarding the Company profile, opening, salary structure & other facilities etc. on the day of Campus drive.
7. The **Company/Third Party** shall make own necessary arrangement for boarding, lodging & transportation of authorized company representative and their team attending the Campus drive.
8. The **Company/Third Party** shall share the joining status of the selected candidates.
9. A Nodal Officer may be nominated by the **Company/Third Party** to act as linkage between the Company & CPC, Odisha. The nomination can be changed at any time, in line with the Company preference, without any prior notice and discussion.
10. The database of the students participating in the Campus drive shall not be provided to others without the consent of CPC, Odisha.
11. After joining of the candidates CPC will not be held responsible for any misconduct shown by them, and any misconduct can be dealt with as per law.
12. The company, through its authorized representative, can take up recruitment of fresh trainees from any college, institutes and from open market, as practiced currently whenever they deem fit.
13. The parties hereby acknowledge and agree that this **MoU** is just an extension of Campus recruitment arrangement and under no circumstances, either parties are entitled for any legal recourse for any issues or disputes related to campus recruitment. Either party is also shall not be entitled for any legal



remedies, or adjudication or for any other resolution at any time in India or international in respect of the campus recruitment matters.

14. All notices to be given under this MoU by any party to the other shall be in writing in English language and sent to the other part at the addresses set forth above by email to the addresses mentioned above.

15. This Agreement can be amended, by either party after discussions and agreement by a written consent of the other party.

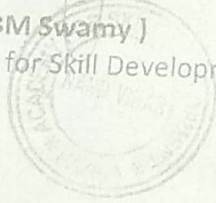
