MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called the 'MoU') is executed on this _____ day of November 2018.

BETWEEN

Central Placement Cell, Director of Technical Education & Training, Odisha having its address at Killa Maidan, PO: Buxibazar, Cuttack-753001, Odisha, India under the control of Skill Development & Technical Education, Government of Odisha

(hereinafter called "**CPC, Odisha**" which expression, shall, unless repugnant to the context or meaning thereof, include its successors and assignees, as the case may be) of the **First Party**.

AND

Suzuki Motor Gujarat Private Limited, a company incorporated under the Companies Act, 1956 and regulated under Companies Act, 2013 and having its registered office at Block no. 334 & 335, Hansalpur, Near Becharaji, Taluka Mandal, District Ahmedabad- 382130, Gujarat, India (hereinafter called "**SMG**") which expression, shall, unless repugnant to the context or meaning thereof, include its successors and assignees, as the case may be) of the **Second Party**;

WHEREAS SMG is engaged in the business of manufacture of motor vehicles and spare parts in the State of Gujarat. .

WHEREAS CPC, Odisha has a vision to get the students pursuing Diploma and ITIs Education & Training placed in reputed Companies. And also facilitate Companies in form of providing database of interested students against openings of that Company and making arrangement for Campus drives to be organized centrally.

NOW THEREFORE, both parties hereto after intense discussion have desired to work together in common areas as per following terms and conditions:

- The **MoU** shall be effective from the date of its signature.
- The period of **MoU** shall be for three years to be extended by mutual consent for a further period of three years or more. This MoU can be terminated on mutual consent of both the parties hereto in writing.
- **CPC, Odisha** proposes to conduct campus drive centrally / decentrally for the benefit of the students pursuing the Diploma Education & ITI Training across the State of Odisha by providing necessary logistic support with other technical & knowledge support from SMG.
- SMG shall register in CPC website i.e. www.cpcedtet.nic.in with a unique user ID and password, provided by CPC, Orissa and shall conduct at least one campus drive in a year through CPC, Odisha.
- SMG should provide their requirement with other detail criteria for the Campus drive in the official portal of CPC, Orissa.
- SMG shall depute the Companies' HR along with their team for presentation regarding SMG profile, opening, salary structure and other facilities etc. on the day of Campus drive.

- SMG shall make its own necessary arrangement for boarding, lodging and transportation of the HR and their team attending the Campus drive.
- SMG shall inform the joining status of the selected candidates and also update information against all the hired candidates in the official portal of Central Placement Cell after completion of minimum six months service / training period.
- A Nodal Officer may be nominated by SMG to act as linkage between SMG and CPC, Odisha.
- The database of the students participating in the Campus drive shall not be provided to others by any party hereto without the consent of the other party to this MoU.
- Legal entitlement (Background check, police verification etc.) of skill professional hired through CPC, Odisha should be borne by SMG.
- After joining of the candidates, CPC, Odisha will not be held responsible for any misconduct shown by them, and any misconduct can be dealt with as per law.
- On termination / expiry of the MoU, each of the parties hereto shall promptly return the other party's Confidential Information marked as confidential and copies in physical form in its possession, to the other party. If any, each party hereto shall destroy the soft copies and the same to be informed in writing to the other party.

- All notices to be given under this **MoU** by any party to the other shall be in writing in English language and sent by registered mail / postage prepaid addressed to the other part at the addresses set forth above and also by email to the addresses mentioned above.
- That the parties hereto shall subject to the rules & regulation that are now in force & that may be framed by the first party from time to time, further if any deviation of **MoU** by the second party shall be liable under criminal law.
- This MoU will be governed by the Indian laws and the Courts of Cuttack shall have exclusive jurisdiction over all matters pertaining to this MoU.
- This MoU shall not be amended, assigned or transferred by either party without the written consent of the other party.
